




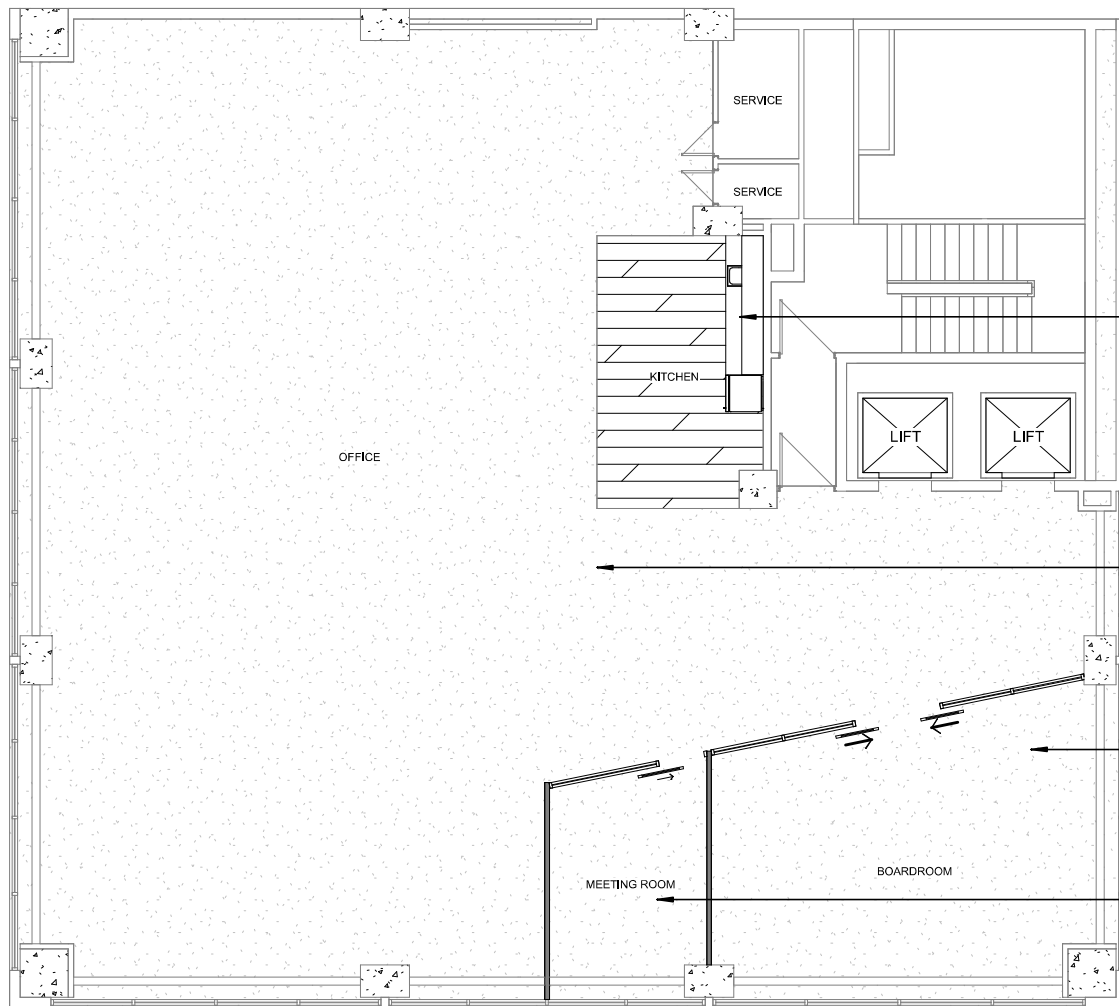



-  EXISTING WALL TO REMAIN

GENERAL NOTES

- PROVIDE ADDITIONAL SUPPORT IN PARTITIONS WHERE PARTITIONS INTERSECT.
- PROVIDE ADDITIONAL SUPPORT IN PARTITIONS TV/AV EQUIPMENT ARE WALL MOUNTED.
- SUPPORT DOOR FUNCTION BY PROVIDING ADDITIONAL FRAMING ABOVE THE CEILING GRID TO SLAB, BRACE ENDS OF ADJACENT WALLS OF DOORS NEAR CORNERS.
- APPLY CLEAR SILICONE TO ALL GLASS BUTT JOINTS.
- ENSURE ALL EXISTING CAVITIES AROUND SOUND INSULATED PARTITION ENDS (ie. PERIMETER DUCTS) ARE FILLED WITH INSULATION TO MATCH THAT USED WITHIN SOUND RATED PARTITIONS.
- ALL NEW AND EXISTING WALLS IN CONTRACT TO BE SKIMMED TO LEVEL 4 FINISH READY FOR PAINT FINISH.
- WHERE NEW PARTITION EXTEND EXISTING PARTITIONS, REMOVE ALL EXISTING SKIRTINGS AND REPLACE WITH NEW.
